- **Food and Craft Booths are 12' x 14'**
- **Commercial Food Booths are 16' x 16'**
- Vendors must provide all set-up equipment
- **All materials MUST fit inside designated booth space**
- **GENERATORS ALLOWED / LIMITED SPACES**
- Working out of personal vehicles is not permitted
- Prohibited items include stink bombs, poppers, silly string, rubber bands, and projectiles of any kind. The committee reserves the right to refuse sale of any item deemed objectionable.
- Vendors may request the specific booth assignment and every effort will be made to accommodate this, but it is not guaranteed. Remember, first come, first served.
- **Vendors using warming or cooking devices MUST have a charged and inspected appropriate fire extinguisher in their booth area.**
- **NO PETS ALLOWED ON FESTIVAL GROUNDS... SERVICE DOGS ONLY!!!**
